



Welcome to the Metro Community Housing Scholarship Program

The scholarship program is open to anyone housed by Metro and who is seeking to undertake vocational study.

Metro Housing firmly believes in the value of education, but also recognises the serious financial barriers that can prevent enrolment in study.

Metro Community Housing's scholarship program is aimed at providing financial assistance for clients who wish to pursue education opportunities which will enable them to attain the skills to return/improve employment opportunities. It is also open for your children to promote a positive experience of school and to advance their education and employment opportunities.

Who can apply?

- You must be 16 years or over and:
- A resident of Metro Community Housing
- Make an application for a course/item that will improve your employment or child's school experience.
- Have no arrears or be on a consistent payment plan.
- Not be the recipient of a FACS or other* scholarship in the same year you are applying for a Metro Housing Scholarship.

- *For example university or TAFE

How much can I apply for?

We are offering scholarships from \$500 to \$1000 to be used towards course fees or a directly related expense.



These scholarships will be awarded to up to 10 tenants annually.

In most cases the funds will be paid directly to the chosen education institution, or on production of a receipt or tax invoice for costs such as textbooks.

Recipients of the scholarship will receive payment on completion of each semester, except in special circumstances.

What can I apply for?

- Senior high school studies (year eleven and twelve)
- A range of vocational university or TAFE courses
- Tertiary education bridging courses (generally provided through TAFE or university summer or winter school)
- English language courses, e.g. English in the Workplace (run through TAFE)
- Accredited vocational training through a private education institution e.g. barista training, forklift license, large vehicle license, food preparation course.
- You can apply on behalf of your children for materials related to their school participation, these include:-
 - Textbooks, tutoring, school supplies, travel, excursions, study camps and school sporting fees.



How to Apply

- You can apply for yourself or on behalf of your child who is a member of your household.

The Board of Directors and Manager will review each application, and will award the funds based on a combination of demonstrated need, fulfilling employment opportunities and enhancing their child's experience of school. Clients can only apply once a year.
